### Voted in Daphne

• Liz made a motion to vote in Daphne as a voting member, given two absences. Dan seconded, motion passed.

#### **Permits**

Exeter Road Warehouse Project (Ian MacKinnon, Jones and Beach)

- Ian brought a lot of reports as follow up to his presentation last month, including plant records and animal records relevant to the site.
- Ian made note that the original wetland delineation was 2013, then the property was logged a few years later, and the wetland has expanded since then.
- Gabe questioned when we will receive the remainder of the outstanding reports. Ian specified this was the wildlife assessment?
  - Ian suggested the report could be done quickly, but the report might sit with Fish and Game for six months.
- Ian said as part of the permitting process, if anything changes on the plan, they would have to come back in front of the boards.
- Gabe questioned the timing of the permits.
  - Ian said they would like to work everything out with the local boards before they submit to the state.

- Ian said we could word a condition to any approval that any change in the plan would require them to come back to the ConComm.
- Joe mentioned the ECC generally likes to avoid permanent wetland impact.
- Gabe summarized that he'd like them to take a look at avoidance of the impacts, possibly shrink the footprint and shrink the impact.
- Liz would like a copy of the wildlife assessment as it will be submitted.

# Sig Sauer Indoor Range (Joe Coronati, Jones & Beach)

- Joe presented updated plans for the indoor range at Sig Sauer.
- Joe said the wetland out there is flat, and not flowing.
- At 7400 sq ft they are below the state's requirement to have wetland mitigation (state requirements start at 10k)
- Joe noted his meeting with the planning board is in December.
- Liz makes a motion to recommend approval of the plan as submitted, Ben seconded. Motion passed.

# Declination Letter for Society of Protection of NH Forests

- Regarding a conservation easement at Miriam Jackson park.
- The Forest Society would like a formal letter of "no objection" to removing themselves from their obligation to this property.
- Liz made a motion that the town write a letter to the Forest Society relieving the Forest Society of their obligation and interest in Miriam Jackson park. Gabe seconded. Motion passed.
