The parcel is located at 232 Main Steet in the Rural Residential Zone. Tax Map 022, Lot 058.
- b. <u>46 MARTIN ROAD, LLC</u> Variance under Article 3 Section 3.8.A.7.d of the Zoning Ordinance to permit the installation and use of a septic system for a multi-family development. The parcel is located on 46 Martin Road in the Industrial Commercial Zone. Tax Map 036, Lot 023.
